You may wish to seek professional advice to help complete this affidavit. In order for the Official Assignee to be in a position to make an informed decision, the following particulars should be included in your affidavit:

- The reason for your application.
- The name(s) of the business owner(s).
- Your relationship to the business owner(s).
- The name and nature of the business.
- What money or assets of your own are you contributing to the business?
- A full description of your duties and responsibilities.
- Whether your duties will include raising credit on behalf of the business.
- Whether you will have cheque signing authority on the business bank account.
- Your anticipated income.
- Your pre bankruptcy employment including role, duties, responsibilities and income.
- The cause of your bankruptcy.
- Whether or not contributions to your bankruptcy creditors will be available.
- Such other particulars as the Official Assignee may require including a copy of your employment contract.

Please note that if consent is given it will be in written form. You must not take part in a managerial role until such time as this consent is received by you.
