WHO REALLY RIPPED OFF KIDSCAN?

Regular readers will recall that Hell Pizza got into a spot of bother in respect to an alleged charity called KidsCan. I [blogged about it at the time](#) based on media stories.

What I am about to reveal is the real story behind the scam at KidsCan and the involvement of Matt Blomfield in collusion with Stu "McMillions" McMullin to [throw another director under the bus](#) for the whole sorry issue.

I am starting the story that I will break over coming days with a exploration of the truth behind the story, a truth that so far hasn't been reported. I will also explain using emails and documents exactly why the truth never came out.

With all of these posts, I will post extracts from emails, but also [the complete email trail](#) to show true context. This has never been done by the media, and I will explain why in a separate post in coming days.

The real story begins with an email confirming arrangement made between Warren Powell (Otis) and KidsCan and Warren Powell's reply.

As you can see KidsCan is confirming the details of the discussion and Warren Powell is agreeing (in case like YES) to some of the items and saying maybe to others. Note the amount of the donation is \$5000.

Warren Powell then emails everyone in reply to Jan's email above. Note the \$5000 is still \$5000 and undecided. We will learn about "Weeman" and his caravan adventures in a subsequent post.

The event is then held. Warren Powell attended the even, made pizza as promised, though the live crosses never eventuated as promised. Neither were any of the promised product placements or brand exposure that KidsCan promised Hell. Matt Blomfield and "Weeman" were in attendance and operate the caravan on the night and were in charge of the mop up.

Jan Clark then emails Matt Blomfield and Stu McMullin asking for a wash up. Note, this is soon after forwarded by Matt Blomfield to [Tania McRae](#) (partner of [Yuta Iguchi](#) (talks himself up as some sort of [Yakuza](#) enforcer, quite how someone who is shorter than Winston Peters can be an enforcer is beyond me), shareholder and director of various failed companies associated with Matt Blomfield). Why would he do this? She is a graphic designer in a company that provided graphic design services, including the Mark Hotchin "Greed" billboard to Hell. but again why did he email her? More on this later.

This is the set up. Remember from the email trail above that Warren Powell handed everything over to Matt Blomfield to organise and somehow under Matt's watch the "maybe" donation of \$5000 was increased and confirmed as \$10000, plus all the product on top. Stu and Matt clearly know now that the bill has to be paid that "Otis" or Warren Powell is going to produce one of [his famous blunt emails](#) which they can then use to throw Warren under the bus and remove him from Hell.

Warren Powell does hit the roof, because what has eventuated is nothing at all like what he agreed to.

This is the email that made KidsCan and Matt Blomfield in collusion with Stu McMullin create a massive news story. Matt Blomfield [packages up all of this and shops it to the media](#), some months later. Note, that in Bevan Hurley's story the first thing he mentions is the dorks email. In later posts I will outline how Matt Blomfield ghost wrote articles for a number of journalists including Bevan Hurley.

Kidscan in their media statements and comments from Jan Clark to the media paint the picture that Warren Powell is behind all the stuff ups...when as you can see from the emails Warren Powell was only involved at the start and at the end. Sure he sent blunt emails but only after his own team let him down and then sold him out. The reasons for this will become apparent as I outline the rest of this sorry little tale.

For the record Kids Can painted themselves as pure victims in all fo this, and on their website they [claim that 100% of donations go to the children](#). This is wrong. The \$15 per month relates to the In Our Own Backyard programme, not Kidscan as a whole. This programme was introduced in 2010 I think then re-launched in 2011.

100% of the IOOB programme DOES go directly to the children - they do not claim for any admin or fundraising costs out of these donations. This is quite clearly shown within their financial records. How I do I know - we sponsor 4 NZ children every month so I make it my business to know where my money is going.

As a wider charity 80% of all funds raised - including the Telethon in 2009 - benefit the children. This is fairly standard when compared to other charities like World Vision etc.

In terms of whether Jan Clarke mislead Hell - I don't think she did. Clearly she was lead to believe that Warren was going to donate more than what he wanted to.

Quite frankly the main thing that these emails tell me as that the Hell guys communicate as effectively as a brick - they are useless and have no basic etiquette when it comes to managing networks. They are clearly the kind of people who have an over inflated sense of self just because they shot up to fame & fortune very quickly. In a word - they are tools and I don't think any of them are without fault.

And while Warren may have been a bit of a victim in all of this he lost my sympathies when he demonstrated a lack of sincere philanthropy & called Kidscan "dorks". A vulgar man part of a vulgar company so good riddance to the lot of them ((& their yummy pizzas!) I say.

Jan Clarke states this in her first email above - the "small sponsorship fee" of \$5k plus GST (which later morphs into \$10k) is "to be paid in return for product placement/exposure on TV."

Warren Powell makes it clear in his replies that it's a MAYBE, depending on whether that placement and exposure happens. It didn't. Please keep up.

Hell pizza will no longer be my preferred Pizza supplier. Literally they can go to Hell. Any [company that rips off a charity](#) doesn't deserve my business.

“ Hell pizza refused to pay \$10,000 the company had pledged to Telethon – after the company's boss asked workmates for advice about how they could avoid paying the “dorks”.

Warren Powell initially agreed that Hell would pay the sum to the KidsCan charity in exchange for “exposure” at the Viaduct headquarters of the Big Night In Telethon in 2009.

Suppliers including Goodman Fielder and Red Bull donated boxes of supplies to the company and Hell staff were asked to volunteer their time for the event.

But after seeing reports that some of the money raised was failing to reach needy children, Powell reneged on the deal, says Julie Helson, chief executive of KidsCan.

Helson said Hell Pizza used negative reports about the charity as an excuse to not pay what it owed.

“He reneged on it and they just didn't pay up,” she said. “We got nothing.

“Powell was so rude to us, he was filthy, really derogatory.”

That is pretty low. Probably the lowest stunt that Hell has tried. They have run offensive billboards, a persecution campaign against Mark Hotchin but now their dirty dealings have come back to bite them on the arse.

“ In the lead-up to the event, Powell wrote to organisers: “Yes, we will give ALL proceeds from the van to Telethon”.

“Yes, we will cover the cost of making the pizza.

“Yes you will see me there, I will be making pizza (best dam [sic] pizza maker in the country).”

Pretty unequivocal. They should front up with the \$10,000. They have certainly paid more than that for their billboards vilifying Mark Hotchin.

“ But in an email dated August 13, several days after the 24-hour fundraiser, Powell changed his tune.

He wrote to colleagues: “So how does this work? We gave away pizza by the dozen to these dorks and raised good [sic] knows how much; now am I expected to give them a chq in return for nothing?

“What do they have in writing and from whom? From below it looks like they have a verbal but that is all.”

That just makes Powell scum, trying to rip off a charity.

“ Even after KidsCan produced an audit showing that all the money was reaching children in poverty, Hell Pizza did not pay the money.

Helson said the charity chose not to pursue a civil action through the courts because that would have cost more than they hoped to get.

"We're in the business of helping kids." Helson said \$10,000 would support 56 children for a year, buying them school meals, shoes, socks, a raincoat and a beanie.

If someone from KidsCan would like to contact me I will happily provide promotion for any of their events free of charge.

Meanwhile might I suggest to the Whale Army that Hells Pizza be removed from their lists of preferred suppliers, indefinitely.

In December 2008 Matthew Blomfield's empire [was about to collapse](#). Westpac was pressing Matt Blomfield for a large sum of money and Matt was telling them that he had some money coming in one of his companies. That company, of which he was a shareholder and director, was Infrastructure NZ Ltd.

With Matt in this company was a fellow called Paul Claydon.

Paul Claydon knows a fair bit about building roads and by all accounts is good at what he does. Matt Blomfield knows a fair bit about scalping cash from businesses and almost nothing about building roads.

It isn't a surprise that they fell out. "Operation Kite" was the result of the falling out. This was how Matt Blomfield was going to pay Westpac. It is ironic that the operation is named for a illegal banking practice called [Kite Flying](#).

To summarise, Matt Blomfield in tandem with advice from his faithful lawyers, and [a number of emails to Waitakere City Council](#) conspired to steal a cheque from a PO Box, using some private investigators.

Matt, on the advice of his lawyer then tried to launder the money but was caught by a vigilant bank. The bank reversed the cheque but Matt had already removed the funds from the account leaving a substantial debt. The bank pursued Matt Blomfield legally for the outstanding negative balance in the account. Matt Blomfield [vigorously opposed](#) the actions of the Bank. Matt Blomfield ultimately lost that case once it was established that his defence had no merit.

There is a dispute between the owner of INFRASTRUCTURE NZ LIMITED. One 50% shareholder and Director Paul CLAYDON is allegedly using funds from the company as his own and is trying to gain 100% ownership of the company.

The other 50% shareholder and Director is Matt BLOMFIELD (of Hells Pizza) and wishes all funds to be deposited into the INFRASTRUCTURE account.

There is a cheque being sent from the Council for circa \$200k to INFRASTRUCTURE Postal Box at North Harbour Mail Centre, Paul Mathews Drive, North Harbour. BLOMFIELD will be at the Post Box at 04.30 hrs on Wednesday 24 December 2008.

In terms of Paragons assistance there is a two phase approach planned:

CONTAIN CLAYDON

We will have a surveillance team on CLAYDON home address at 03.00 hrs and observe him to have a "heads up" on his activities in the early morning of Wednesday 24 December 2008. Initially the mission will be to establish if his vehicle is at home and there are no lights on at the residence.

Any activity is to be communicated to KEREAMA first. KEREAMA is to then communicate to BLOMFIELD.

PROTECTION OF BLOMFIELD

We will have a staff member (Peter KEREAMA 0272910711) on standby ready to attend at BLOMFIELD location if the target CLAYDON rolls. He is to stand down if CLAYDON remains at home and is no threat.

The objective of this agent is to ensure that BLOMFIELD gains possession of the cheque and banks this into the account of INFRASTRUCTURE. This is to be done lawfully and with a focus of preventing any violence or escalation/threat of violence.

The objective is for BLOMFIELD to get the cheque first and to have secure possession of the cheque as soon as it has been delivered by NZ Post to the PO Box.

OTHER DETAILS

CLAYDON is described as a Male Caucasian aged 54 yrs, brown short thinning hair, fit athletic build, 6'2" residing at his "Orchard" located at 279 Omaha Flats Road, Warkworth.

He drive a new model silver Toyota Prado which is typically parked next to the house accessed down a long drive way.

ORAL JUDGMENT OF JUDGE L I HINTON

[1] This was a summary judgment application by the bank that was set down for a half-day defended hearing, following the filing of opposition papers on behalf of Mr Blomfield, which included an affidavit dated 14 January 2010.

[2] Subsequent to the matter being set down for hearing a memorandum has been filed on behalf of the defendant dated 19 February 2010 indicating that following the filing by the bank of evidence in reply the defendant no longer wished to take any further steps in the proceeding, either himself or through counsel. The memorandum states that Mr Blomfield is content to abide by any decision of the Court.

[3] The plaintiff, Auckland Savings Bank Limited, then filed a memorandum dated 24 February 2010 seeking judgment against Mr Blomfield in the circumstances. Today counsel has sought judgment in accordance with paragraph four of that memorandum and I shall return to that in a moment.

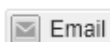
Matt Blomfield ultimately didn't really care because just months later all of his companies were in liquidation and he was in bankruptcy leaving many people, business and banks out of pocket.

Check kiting is a form of **check fraud**, invoking taking advantage of the **float** to make use of non-existent funds in a **checking** or other **bank account**. In this way, instead of being used as a **negotiable instrument**, checks are misused as a form of **credit**.

It is commonly defined as intentionally writing a check for a value greater than the account balance from an account in one bank, then writing a check from another account in another bank, also with **non-sufficient funds**, with the second check serving to cover the non-existent funds from the first account.^[1] The purpose of check kiting is to falsely inflate the balance of a checking account in order to allow written checks that would otherwise bounce to clear.^[2] If the account is *not* planned to be replenished, then the fraud is known as **paper hanging** instead. If writing a check with non-sufficient funds is done with the expectation that they will be covered by **payday** – in effect a **payday loan** – this is called **playing the float**.

Some forms of check fraud involve the use of a second bank or a third party, usually a place of retail, in order to delay the absence of funds in a **transactional account** on the day the check is due to clear at the bank. Such acts are frequently committed by bankrupt or temporarily unemployed individuals or small businesses seeking emergency loans, by start-up businesses or other struggling businesses seeking interest-free financing while intending to make good on their balances, or by pathological gamblers who have the expectation of depositing funds upon winning. It has also been used by those who have some genuine funds in interest-bearing accounts, but who artificially inflate their balances in order to increase the interest paid by their banks.

Big slice of trouble

The menu at Hell Pizza contains dishes named Nemesis, Trouble and Wrath.

But such words could equally be applied to an ugly legal battle over the fast food giant.

The company's former owners are suing the chain's founders and current owners over claims of staff harassment and bogus complaints.

Mark Backhaus and Dennis Jones say their attempts to sell their last remaining franchise store in Albany has been blocked by Hell's original owners.

Their company Flame has filed court papers accusing the men behind the Hell brand of bullying and getting associates to make fake customer complaints.

But the founders hit back, arguing Flame had run "that franchise into the ground" and launching a counter-suit claiming damage to the Hell brand.

The ugly stoush erupted after Flame sold back Hell to its founders Warren Powell, Callum Davies and Stu McMullin last May.

Under the agreement, Flame kept the Albany franchise and was given six months to sell it.

Flame received an offer of \$350,000 from a company called Kai Wen Enterprises, but the bid was rejected by Hell who said that the manager could not speak good enough English or even make pizza dough.

Court documents accuse Powell of conducting "an oppressive campaign of harassment" against the Albany staff. It alleges that Powell and a

business associate spent evenings "monitoring" the store and "verbally harassed the staff to the point that one duty manager resigned".

During peak trading one day last July they insisted that "all orders stop while a special six-pizza order was made with each ingredient weighed before being placed on the pizza".

Staff were allegedly told to leave pizzas to go cold before being delivered, and were once told to throw out all pizza bases in stock for not being fresh - even though the dough had been made that day.

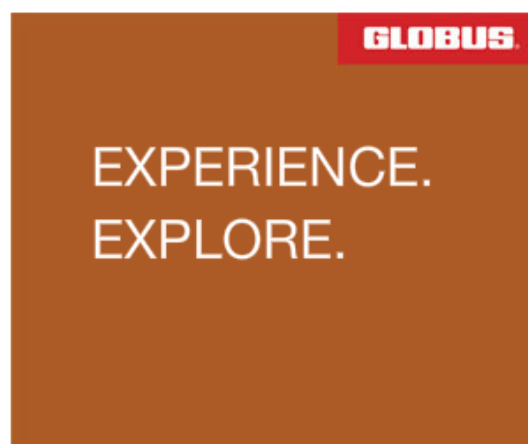

But last night Powell denied he had harassed staff at the Albany franchise: "It's completely untrue. I've been to that store twice and I've only dealt with the managers."

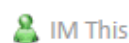
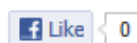
Powell said the proposed manager's English was so limited he came to meetings with a translator.

"When I asked him how long you cook pasta for, his response was for two months. They're trying to make us look like bad operators," said Powell, "but they ran that franchise into the ground. Our customers deserve better."

"We took photos of all pizzas coming out and they were of extremely poor standard," says Powell. "The manager refused to remake them. There's never been any harassment, that's just us protecting the brand. We take quality seriously."

Powell said their counterclaim was seeking the termination of Flame's franchise, compensation for damages to the Hell brand, reputation and business, costs and interest.

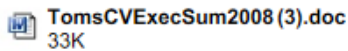

He told Matt Blomfield to go easy on nasty emails to the ANZ. Note that in this Matt Blomfield is still trying to blame Paul Claydon who featured in [Operation Kite](#) for his demise.

The reason I know this are they are attached to an email you sent Paul on the 4th of June 2009. If what I am saying is not correct please let everyone know (this is before you change them remember) I do believe that when I contacted you as a director of the company you said to me that Paul had collected all the files and you had nothing. Based on the questions you asked that seems very strange (Nice way of saying you're a lying really)
2. Lynton's email please explain to me what you are saying in point 6 when you refer to and quote "There are also payments to you (as a director and shareholder) that are described as consulting fees and GST has been claimed on these fees. We don't understand the nature of these transactions" well Lynton I sure as hell don't understand these transaction, I can only assume that this is over and above the \$431,839.54 of drawings and the \$60,000.00 Salary. Anyway my point is as a director and shareholder of the company known as Infrastructure NZ Limited and Contract NZ Limited I ask that you supply all the files you currently hold in the current form to Bob Jones at ANZ National Bank. As you have said It's my right to do this. Over to you Bob maybe this time we can stick to the facts.

3. The Gear. Well based on what I've heard from staff of Infrastructure NZ Limited I understand that Paul has started trading under the company name Infrastructure and Civil Limited. I believe that to be true as it does say that on his business card (happy to supply that if anyone would like to see it) and to firm it up we did find a new accounting files in the office. So how does this relate to the gear? Well he is currently using the gear for new company and he is not charging them so correct me if I'm wrong that would make two counts of conversion one for the money and two for the gear and three which is not conversion but just sucks is I bet he's banking with ANZ National. For those who don't know I've started collecting gear to try and prevent this from happening I very nice six wheeler if you are interested. The good thing about this is as a result Paul has also started hiding gear. Good luck to the bank finding but as usual I expect nothing.

In summary

We have a bank that tells me that they will work with me to solve my Cinderella Issues by way of this very profitable company I own. Then the bank proceeds to assisting with the setting up of the new account and knowingly allows conversion of the cheques to take place. I thank you for this Mr. Daley. Even if this is not the case and Paul has lied and John Daley did not assist, I then notify the Asset Management Team who in turn ignore my complaint when I follow this up with Mr. Jones five months later his response is "Thanks for putting us "on Notice"" Well done Mr. Bob Jones I think its fear to say that the bank is bigger than me. Time Capital NZ Limited (TCNZ) has been independently commissioned to co-ordinate a formal Creditors Scheme of Arrangement. After our initial investigations over the past few weeks, we believe there is a significant upside for Creditors to consider accepting a formal agreement compared to the alternative - the bankruptcy of Mr Blomfield which will probably produce no realisation for Creditors.

After our initial investigations over the past few weeks, we believe there is a significant upside for Creditors to consider accepting a formal agreement compared to the alternative – the bankruptcy of Mr Blomfield which will probably produce no realisation for Creditors.

As we have seen above Time Capital were far from independent and in fact consulted with Mike Alexander and Matt Blomfield extensively in the preparation of the Creditors Compromise. Time Capital were supposed to be the trustee for the creditors.

Now all of that becomes very interesting with this email from Matt Blomfield...where he pays Time Capital \$10,000 that same day they are appointed as the creditors trustee...What could possibly warrant that payment? Is it just coincidental that prior to this being paid Tom Wilson didn't want to do this deal. Mike Alexander was copied on the email involving the payment. Note Matt Blomfield says he will send more...how much and when?

It appears that Time Capital have taken a financial inducement to represent creditors as their trustee. No wonder not a single cent of the \$3.5M has been recovered.

In this email trail below we can see that this whole arrangement was organised by Mike Alexander as a favour for a "client"...who was "in funds". Just a few months later Matt Blomfield went under and all his companies for more than \$3.5 million. But not before Mike Alexander provided [a glowing reference to Stuart Alexander Limited](#).

Tom Wilson says he would like to help despite the later email saying it wouldn't work out...perhaps the initial \$10,000 deposit helped change his mind.

John as per our discussions today and your discussions with and email to Warren I'd just like to clear up the following:

* We have been working across all of Carl's businesses to try and retrieve/save any value/equity that exists. Albeit that this has been for the most part futile.

* On your instruction I contacted Gough Finance and made them aware that they had gear that was at risk and was owned by a company which had been in liquidation for almost 12 months.

* Goughs then issued repossession warrants and I then subcontracted Dion and Rob to collect the gear for Goughs. Excluding one truck, one digger and a boat (which Carl Storm has told me is in his possession) all the rest of the gear has been picked up. I would go so far as to say without my assistance several of the items secured by Gough and Marac would not have been returned.

* At the point that we realized Carl Storm's bankruptcy was fast approaching I took his place as director and shareholder of the company so as to be in a position to liquidate the company. I have discussed this with you and await the return of ENZ's files so that they can be reviewed by Knight Coldicutt. At which point I would foresee that the company will be placed into liquidation. Under the advice of my lawyers I will be making contact with the official assignee and any equity that is realized from the liquidation will be returned to them.

At all times I have kept you informed on what is going on. I do not see any conflict of interest whatsoever. As you can see from this email I have done nothing more than my job as a full service consultant and will continue to take this project through to its completion albeit for little return.

BLOMFIELD FILES: THE PERFECT STORM CTD.

BLOMFIELD FILES: THE PERFECT STORM, CTD

Yesterday I talked about [a missing digger and truck](#) that was part of the assets of the Storm Group. Matt Blomfield and Dan Blomfield essentially blamed Carl Storm for the missing digger, playing possum with the liquidator.

Late yesterday I received a communication from the liquidator that informed me that based on the information that I had provided him from the files I have that a digger and truck had been recovered.

Now this is where it gets interesting.

The Digger and Truck were recovered from Whakatane from an innocent party who is now thousands of dollars out of pocket and now has no digger or truck.

They were a Isuzu FXZ1400 TRUCK and ZX 50u Excavator (similar to [this image](#))

The vendor to the man from Whakatane was a Kevin Ries (ex Carl Storm and Dan Blomfield) who had filed off the Engine and chassis numbers.

Here is [Kevin Ries CV](#) as prepared by Matt Blomfield in 2008 two years before the digger and the truck went missing. Note the letterhead.

The victim had put up his boat as the purchase price. It was a Bayliner 6.8 metre with Volvo inboard/outboard. This was valued at \$40k for the swap. The Truck and Digger had a combined value of about \$33k. I know where this boat is too.

The last person seen with the Digger and Truck was Matt Blomfield when he rang the recovery agent to say he had located them some two years ago. They disappeared a short while later.

As you now know they have been recovered and contrary to the evidence I supplied yesterday they were not stolen by unknown parties they were in fact converted by people who were known associates and trusted confidantes of Matt Blomfield for a boat which is currently in the possession of a relative of Matt Blomfield.

I am not sure what the actual legal situation for Matt Blomfield is with this or what possible crimes have been committed. Conversion is certainly one that springs to mind, as is filing a false police complaint.

The digger and the truck issue is just the tip of the iceberg with the Storm Group.

Here is a plan orchestrated by Mike Alexander of Knight Coldicutt whereby it is outlined how the assets of The Storm Group and associated entities were going to be dispersed to to evade creditors post Carl Storm's bankruptcy and how Matt Blomfield was to benefit from these machinations.

I will post more on The Storm Group and how the plan panned out in future posts.

Readers will remember that [Matt Blomfield laid a complaint](#) with the Police alleging that I was in receipt of stolen property, and that related to a burglary and theft from his office around February 2010.

This morning I received an email request from Constable Marty Guest from North Shore CIU. He asked me to call him.

Later this afternoon Constable Guest rang me back to tell me that this was really a civil matter and since the files I had were copies and that I didn't have possession of the originals even though I know who does I was not doing anything illegal. As far as he was concerned and that of his superiors it was a civil matter.

He did warn me that I should not in any way agree to meet Matt Blomfield...I didn't find this strange at all considering his [previous record of violence](#) and intimidation.

We discussed how I could arrange the return of some personal items that are unrelated to the investigation that I am conducting into the nefarious life of Matt Blomfield. I have agreed to courier those items to North Shore police. I have also agreed to provide a copy of some personal data if Matt Blomfield supplies a portable Hard Drive.

The bottom line is the Police do not believe that I have any stolen information and they consider this to be a civil matter.

No doubt the 142 emails that Matt Blomfield has previously sent to and mention North Shore Police that I discussed with Constable Guest may have given them an indication that Matt Blomfield has form when it comes to paying vexatious complaints with authorities.

Matt Blomfield however should not expect that to be the end of his dealings with the Police, as there is a small matter of [conversion of a digger, truck](#) & boat (still at large).
