Thank you for your email of today’s date in regards to the Whale Oil website (copy attached).

Please accept this letter as “notice” under the New Zealand Defamation Act 1992 that the following stories are mostly defamatory and are subject to current court proceedings (CIV – 2012-092-1969). You have been provided a copy of the Statement of Claim and supporting documentation on the 29th of October 2012.

To continue to allow this content to be displayed by all or any websites under the control of Google New Zealand Limited (1786635) is to commit defamation by your own publication.

Could you please remove these stories from the Google.co.nz website and any other websites under your control immediately.

In your email you have stated *“Additionally, you have not explained what statements on this page you are suggesting are false and defamatory and the reasons why these statements are false and defamatory in the context of the page as a whole”*. The statement of defence contained a list of what I believe are defamatory statements. This is yet to be determined by the courts.

It is my view that all of the stories are highly defamatory.
